Carbide material will be controlled via TMS-CU-CBD to improve quality, so that inferior tools do not infect LM factories. LM factories have had serious failures and issues with inferior grade carbide tools being utilized, thus affecting cost & quality of the tools being used including wear-life. This is also a risk to product that is being machined using tools made from inferior/insufficient grade carbide.
