If any change in the availability of leased facilities due to loss, destruction or damage, or any change in the terms of the facilities leases identified in this Clause, or any successor lease, causes an increase in the cost of, or the time required for, performance or any part of the work under this contract, or both, the SELLER shall be entitled to an appropriate equitable adjustment under this Contract.
